

# ORDINANCE 654

## AMENDING ANALOG CABLE TELEVISION RATES

**WHEREAS,** The installation of new digital equipment has changed available methods of accessing the HITEC cable network, and;

**WHEREAS,** The City Council of the City of Hawarden finds that utility rates should be updated to accommodate these changes, and;

**WHEREAS,** The City of Hawarden's cable television service will remain at one of the lowest rates in the Hawarden area.

**BE IT ORDAINED** by the City Council of Hawarden, Iowa as follows:

**Section 1. Amendment.** The City of Hawarden Code of Ordinances, Chapter 113, Section 9 is hereby amended as follows:

**Section 3. Repealer.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

**Section 4. Severability.** If any section, provision, or part of this ordinance shall be adjudged to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof, not adjudged invalid or unconstitutional.

**Section 5. Effective Date.** This ordinance shall be in effect after its final passage, approval, and publication on July 19th, 2008.
