RESOLUTION 2021-15

A RESOLUTION FOR APPROVAL OF THE FY22 MAXIMUM PROPERTY TAX DOLLARS LEVIED IN THE CITY OF HAWARDEN.

WHEREAS, the City Council of the City of Hawarden have considered the proposed FY22 city maximum property tax dollars for the affected levy total, and

WHEREAS, a notice concerning the proposed city maximum property tax dollars was published in the Hawarden Independent on March 18, 2021 as required and posted on city web site, www.cityofhawarden.com and social media account, www.facebook.com/hawardeniowa,

WHEREAS, a public hearing concerning the proposed city maximum property tax dollars was held on March 31, 2021,

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Hawarden that the maximum property tax dollars for the affected tax levies for FY22 shall not exceed the following total:

Total maximum levy for affected property tax levies – \$15.04454

Total maximum property tax money for the General Fund - \$832,649.00

The Maximum Property Tax dollars requested in the total maximum levy for affected property tax levies for FY22 represents greater than 102% of the Maximum Property Tax dollars requested for the current FY21.
