

**AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF HAWARDEN, IOWA BY CHANGING THE COMPENSATION OF THE CITY COUNCIL.**

**BE IT ENACTED** by the City Council of the City of Hawarden, Iowa:

**SECTION 1. SECTION MODIFIED.** Section 17.06 of the Code of Ordinances of the City of Hawarden, Iowa is repealed and the following adopted in lieu thereof:

**17.06 COMPENSATION.** The salary of each Council member is two thousand two hundred fifty dollars (\$2,250.00) per year, payable annually.

(Code of Iowa, Sec. 372.13 [8])

**SECTION TWO. SEVERABILITY CLAUSE.** If any section, provision of part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION THREE. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law and at the beginning of the term of the Council members elected at the next election following adoption of this Amendment.


**15.04 COMPENSATION.** The salary of the Mayor is six thousand seven hundred fifty dollars (\$6,750.00) per year, payable annually.


